MBBS and BDS year 5 and beyond

Tuition Fees

- Tuition Fee Grant from NHS up to £9250 – non income assessed and non repayable

Living costs

- NHS Grant - £1000 – non income assessed and non-repayable
- NHS Bursary – up to £3191 living away from home or £2207 at home– fully income assessed and non-repayable – sliding scale £24,279 parental income (full bursary) up to approx. £55,000 (no bursary)
- NHS Extra Weeks Allowance – £108 a week, living away from home in London, or £56 a week living at home - income assessed and non-repayable
- Student Finance Reduced rate maintenance loan - £3,558, or £2,724 (final year) living away from home rate or £1,902 or £1,443 (final year) living at home rate – non-income assessed and repayable.
- NHS Supplementary grants for those with disability, children or adult dependants – income assessed apart from Disabled Students Allowance. All non-repayable.

Graduate Entry Programme year 1

Tuition Fees

- No funding for the first £3465 of fees – need to self-fund
- Tuition Fee Loan from Student Finance to cover the difference up to total fee (£5785)

Living costs

- Full rate Maintenance Loan from Student Finance England – partly income assessed and fully repayable (see previous page)
- Queen Mary Bursary (subject to household income) – income assessed and non-repayable (see previous page)
- Supplementary grants for those with disability, children or adult dependants – Student Finance England. Income assessed apart from Disabled Students Allowance. All non-repayable.

Graduate Entry Programme years 2, 3 and 4

Tuition Fees

- Tuition Fee Grant from NHS up to £3715
- Tuition Fee Loan from Student Finance to cover the difference up to total fee (£5535)

Living costs

- NHS Grant - £1000 – non income assessed and non-repayable
- NHS Bursary – up to £3191 living away from home or £2207 at home– fully income assessed and non-repayable – sliding scale £24,279 parental income (full bursary) up to approx. £55,000 (no bursary)
- NHS Extra Weeks Allowance – £108 a week, living away from home in London, or £56 a week living at home - income assessed and non-repayable
- Student Finance Reduced rate maintenance loan - £3,558, or £2,724 (final year) or £1,902 or £1,443 (final year) living at home rate – non-income assessed and repayable
- NHS Supplementary grants for those with disability, children or adult dependants. Income assessed apart from Disabled Students Allowance. All non-repayable.

5 year MBBS or BDS as a second degree

- Years 1 - 4: No funding for tuition fees – need to fully self-fund £9250 a year. Living costs: Student Finance Maintenance Loan, Queen Mary Bursary (subject to household income) – see previous page. Plus supplementary grants (children, disability etc)
- Year 5 – same funding as first degree 5th year and beyond – see above
